(1) **IPACE STATEMENT** Contributions to IPACE of \$20.00 may be used to support candidates for local or state office. These contributions are voluntary and not required as a condition of membership in any organization. A refund of this amount may be obtained if written notification is given by the member to his/her regional UniServ office to be processed through IPACE, 100 E. Edwards St., Springfield, Illinois 62704-1999, prior to December 31st of the current school year. IPACE refund request forms can be obtained from the Government Relations Department at the Illinois Education Association-NEA.

(2) **NEA FCPE STATEMENT** The National Education Association Fund for Children and Public Education (NEA FCPE) collects voluntary contributions from Association members and uses those contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of education who are candidates for federal office. Contributions to NEA FCPE are voluntary; making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. Although NEA FCPE requests an annual contribution of \$10.00, this is only a suggestion. A member may contribute more or less than the suggested amount, or may contribute nothing at all, without affecting his or her membership status, rights or benefits in NEA or any of its affiliates. Federal law requires NEA FCPE to use its best efforts to collect and report the name, mailing address, occupation and name of the employer for each individual whose NEA FCPE contributions aggregate in excess of \$200.00 in a calendar year. Federal law prohibits NEA FCPE from receiving donations from persons other than members of NEA and its affiliates, and their immediate families. All donations from persons other than members of NEA and its affiliates, and their immediate families, will be returned forthwith.
