ANNUAL VOLUNTARY IPACE CONTRIBUTION (B)*

Contributions to the Illinois Political Action Committee for Education (IPACE) may be used to support candidates for local or state office. These contributions are voluntary and not required as a condition of membership. If you would like to contribute, please check one of the payment methods below.

Payment method (check one):
